ORDINANCE NO. 2025-20**

AN ORDINANCE ESTABLISHING A RESTRICTED PARKING SPACE FOR USE BY HANDICAPPED PERSONS AT PROPERTIES LOCATED AT 1400 FOURTH AVENUE, 1217 FIRST AVENUE, AND 12 AVENUE A IN THE CITY OF ASBURY PARK, AND AMENDING AND SUPPLEMENTING SECTION 7-36, ENTITLED, “HANDICAPPED PARKING,” OF CHAPTER VII, “TRAFFIC,” OF THE “REVISED GENERAL ORDINANCES OF THE CITY OF ASBURY PARK, NEW JERSEY.”

WHEREAS, the City of Asbury Park (the “City”) has been requested to create handicapped parking spaces located in front of property located at 1400 Fourth Avenue, 1217 First Avenue, and 12 Avenue A in the City, on the Asbury Park City Tax Map, which handicapped parking space shall be located 20 feet on center therefrom; and

WHEREAS, pursuant to N.J.S.A. 39:4-197.5, a municipality may, by Ordinance, establish restricted parking space(s) in front of residences, schools, hospitals and other public buildings, and in shopping and business districts, for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles pursuant to the provisions of N.J.S.A. 39:4-205, when using a motor vehicle on which is displayed a certificate, for which a special vehicle identification card has been issued pursuant to N.J.S.A. 39:4-206; and

WHEREAS, the Asbury Park Police Department has reviewed and approved this request; and

WHEREAS, the City therefore wishes to designate additional restricted parking spaces for use by handicapped person(s) at the aforesaid properties, and to amend and supplement Section 7-36, entitled, “Handicapped Parking,” of Chapter VII, “Traffic,” of the “Revised General Ordinances of the City of Asbury Park, New Jersey,” accordingly.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED, by the Mayor and City Council of the City of Asbury Park, in the County of Monmouth and State of New Jersey, as follows:

1. There is hereby established a restricted parking space to be located at 1400 Fourth Avenue, in the City, on the Asbury Park City Tax Map, which handicapped parking space shall begin at a point located 25 feet south of the southwest corner of Jeffrey Street and Fourth Avenue, and extending 20 feet south on center therefrom, in accordance with the requirements set forth in this Ordinance.

2. There is hereby established a restricted parking space to be located at 1217 First Avenue, in the City, on the Asbury Park City Tax Map, which handicapped parking space shall

begin at a point located 100 feet east of the northwest corner of New Street and First Avenue, and extending 20 feet south on center therefrom, in accordance with the requirements set forth in this Ordinance.

3. There is hereby established a restricted parking space to be located at 12 Avenue A, in the City, on the Asbury Park City Tax Map, which handicapped parking space shall begin at a point located 352 feet south of the southeast corner of Adam Street and Avenue A, and extending 20 feet south on center therefrom, in accordance with the requirements set forth in this Ordinance.

4. The City Engineer is hereby designated to determine whether or not the said parking spaces and the erection of any signs associated therewith conform to the current standards prescribed by the Manual of Uniform Traffic Control Devices for Streets and Highways, as adopted by the Commissioner of Transportation, and any other Department of Transportation rules and regulations governing parking spaces and signs, and shall certify his approval of the same to the Commissioner of Transportation in accordance with the requirements of N.J.S.A. 39:4-8.1.

5. The City is authorized to erect appropriate signage to designate the handicapped parking spaces established herein and may mark the street appropriately.

6. Any signs erected or street markings employed to identify the subject parking space shall clearly and conspicuously state "Parking for Handicapped Persons Only."

7. Section 7-36, entitled, "Handicapped Parking," of Chapter VII, "Traffic," of the "Revised General Ordinances of the City of Asbury Park, New Jersey," is hereby amended and supplemented to include the following:

Jeffrey Street	South	1400 Fourth Ave. Asbury Park City Tax Map, which handicapped parking space shall begin at a point located 25 feet south of the southwest corner of Jeffrey Street and Fourth Avenue and extending 20 feet on center therefrom
First Avenue	North	1217 First Ave. Asbury Park City Tax Map, which handicapped parking space shall begin at a point located 100 feet east of the northeast corner of New Street and First Avenue and extending 20 feet on center therefrom
Avenue	A West	12 Avenue A Asbury Park City Tax Map, which

handicapped parking space shall begin at a point located 352 feet south of the southeast corner of Adam Street and Avenue A and extending 20 feet on center therefrom

8. On or before January 15th of every year (or the first weekday thereafter), the applicant shall provide proof to the City of Asbury Park Police Department that the handicapped parking space is still needed at the subject property. A failure to do so may result in the City’s termination of the designated handicapped parking space.

9. The City reserves the right to terminate the designation of the within handicapped parking space at the City’s discretion.

10. All other Ordinances or parts of Ordinances that are inconsistent herewith are hereby repealed to the extent of such inconsistencies.

11. In the event that any portion of this Ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the Ordinance actually adjudged to be invalid, and the remaining portions of this Ordinance shall be deemed severable therefrom and shall not be affected.

12. This Ordinance shall take effect upon final passage and publication in accordance with the law.

13. A certified copy of this Ordinance shall be provided to the Commissioner of Transportation within thirty (30) days of the adoption thereof.
