

ORDINANCE NO. 5129

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF THE CITY OF LUFKIN, TEXAS, BY CHANGING THE ZONING TO “APARTMENT” FOR PROPERTY DESCRIBED AS PART OF THE SERNA NORTH RAGUET SUBDIVISION, BLK 1, LOT 1 (0.936 ACRES) AND ADDRESSED AS 615 NORTH RAGUET STREET.

WHEREAS, the City Planning and Zoning Commission of the City of Lufkin, Texas, after due notice and hearing, recommends that the hereinafter described land be granted a zone change; and

WHEREAS, the City Council of the City of Lufkin, Texas, after receiving such recommendation, caused a notice, stating the date, place, and time thereof, of a public hearing on such proposed zone change to be published in the Lufkin Daily News, a newspaper published within the City of Lufkin, Texas, such publication being more than fifteen (15) days prior to the date of such hearing which was held in the City Hall in the City of Lufkin, Texas, on the 5^h day of August 2025; and

WHEREAS, at such a public hearing each person present and interested in the proposed zone change was given an opportunity to be heard by the City Council; and

WHEREAS, the City Council of the City of Lufkin, Texas, after giving due consideration to the recommendation of the City Planning and Zoning Commission and the statements made and facts brought out at such hearing on such proposed zone change, and further, after giving due consideration to the orderly growth and development of the City of Lufkin, Texas, having decided that it is to the best interest of the citizens of the City such zone change be granted.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LUFKIN, TEXAS:


Section I

That the Zoning Ordinance of the City of Lufkin, being Ordinance Number 3368 of the Civil Ordinances of the City of Lufkin, and as recorded in Volume 40 of the Civil Ordinances of the City of Lufkin, Texas, be, and the same hereby is amended, so that property is zoned to “Apartment” on property addressed as 615 N Raguet Street.

Section II

The City Planner is hereby designated and ordered to change the official Zoning Map of the City of Lufkin to comply with these changes.



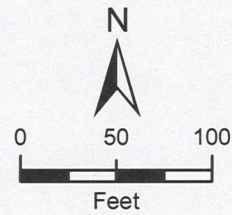
